Description:

In this series of presentations, Dr. Jonathan Iralu, provides an overall infectious disease clinical update focusing on COVID-19, avian influenza, pneumococcal vaccines, and syphilis. Then, Dr. Alithea Gabrellas, MD, reviews the latest guidance provided by the Infectious Diseases Society of America (IDSA) and the Practice Guidelines for the Management of Bacterial Meningitis, to support the effective diagnosis and treatment of patients with meningitis.

Outcomes/Objectives:

1. Identify the widespread occurrence of the emerging threats of COVID-19, Avian Influenza, Pneumonia, Syphilis and Meningitis
2. Evaluate and select appropriate workup for patients with meningitis.
3. Examine treatment considerations and preferred approaches for managing patients with meningitis.
